A. Kalamazoo County HHW Contract

Antwerp Township contracts with the HHW center in Kalamazoo County to provide a free service to our residents to dispose of household chemical waste. As a Township resident, the center is open free of charge to dispose of various items. An amendment to the contract was presented asking for approval to continue services for the 2018 calendar year. Monies must be allocated as well. Township Board allocated \$7800 in 2017.
