## F. Clerk Reyna request for supplies / equipment for election

Clerk Reyna submitted a request for supplies in the amount of \$2596.00 for elections. An invoice in the amount of \$7500.00 was also submitted for equipment needed to get the county wide early voting started.

**G.** Proposal by APG, Ben Brousseau for administration of land splits and boundary adjustments Ben Brousseau submitted a proposal in the amount of \$6000 annually to administer all land splits and boundary adjustments in Antwerp Township.

Motion by Cutting, second by Ruzick to offer Ben Brousseau \$4800.00 annually to administer land splits and boundary adjustments for Antwerp Township. Roll call vote; Reyna-yes, Osborne-yes, Cutting-yes, Tarchala-yes, Ruzick-yes. Motion carries.

### H. Proposal for Trail way land acquisition consultant

Clerk Reyna received two proposals

- 1. ORC provided a proposal in the amount of \$66,230.00
- 2. Metro Consulting Associates provided a proposal in the amount of \$53,875.00

# I. Van Buren Conservation District Memorandum of understanding with tire collection

## J. Proposal to fix roof boots and drywall for Township Hall

- 2. Hall Builders provided a proposal for repair of 16 roof boot flashings in the amount of \$3,950.00.

## K. Maple Grove cemetery crack and sealcoat proposal

A-1 Asphalt provided a proposal in the amount of \$6,030.00 to fill the cracks and seal Maple Grove cemetery.
